# City council pushes projects forward, OK's city hall

CHELAN - Following the selection of former mayor Bob Goedde as its choice among eight candidates to fill the District 2 position, the city council turned to the remainder of agenda items including city rates and fees, priority project funding, committee assignments, and an aviation fuel lawsuit.

The latter item, part of the council consent agenda, was addressed earlier at the Jan. 2 workshop and approves a \$1,000 contribution to an action joined by more than three dozen large and small airports accusing the state of improper diversion of aviation fuel taxes.

#### Rate and Fee Resolution

Parks and Recreation Director Paul Horne reviewed a rate and fee

resolution with increases that roughly align with the four percent rise in the Consumer Price Index. Among the changes:

- Annual parking passes increased from \$20 to \$25 for Chelan residents and \$40 to \$45 for residents of the Chelan Valley.
- Seasonal launch permits at the Lakeshore Marina will increase from \$20 to \$30
- Putting course adult rates applicable after 7 p.m.—will go from \$12 to \$15.
- Recreational programs will range from \$35 to \$75 per program, up from \$30 to \$40 previously. AAU card purchases will increase from
- · Picnic shelter rates will increase from \$45 to \$50 for four hours of use and from \$85 to \$95 for eight hours of use.

#### **Golf fees**

A 2020 study formulated a five-year plan to incrementally raise season pass rates while still providing good value to pass holders.

- Annual Pass Single from \$900 to
- Annual Family from \$1,500 to
- Annual Single Twilight from \$500 to \$550.
- Annual Family Twilight from \$700 to \$800.
- · Daily green fees will increase from \$38 to \$44 for off-season play and \$59 to \$70 for peak season play. Daily green fees and annual passes are the most significant course rates. Other rates either remain the same or reflect marginal increases.

# Luge like nowhere else on Bear Mountain

LOUP LOUP SUMMIT - Winter outdoor sports lovers searching for that one-of-a-kind thrill ride will find just what they are seeking in their own backyard on Bear Mountain at the Loup Loup Ski Bowl.

Bear Mountain Luge Sledding opened for the season last Saturday, Jan. 13, with its brand of excitement not found anywhere else. Luge – a French word meaning "sledge" - employs small single or double occupancy sleds that riders sit on, control with their hands, and use their feet for breaking.

The Loup is one of the first and only resorts in the Western US to offer luge sledding," A Loup media release said.

Combine that with a ride in the back of an open-air snowcat to ascend 1.200 feet to reach the starting point of the five-kilometer course and you have a pair of experiences unique to the Bear Mountain variety.

Loup Loup Ski Education Foundation (LLSEF) board secretary Steve Nelson and wife, Julie, came up with the novel and inspired idea for the luge program, now in its eighth year.

"It's kind of a total experience," said Nelson. "An initial education, a little clinic to tell everybody how to do it, then everybody loads in

snowcats - how many people have ridden snowcats? .01 percent of the population - and then the guided trip down by our luge guides."

With twists, turns, and plenty of speed, the course is a thrilling adventure for all ages. "Speed is whatever the sledder

wants because you control it yourself," said Julie who manages the program. "It's really for those who are more adventurous to go faster."

For those adventurous types, whose daring exceeds their skill there is a border fence just like the kind used on ski racecourses to catch errant riders.

Not surprisingly many of the sledders are return clients and multigenerational family groups that have found the perfect experience that any age can enjoy safely. Nelson said the two types of people he hears from the most are the repeat customers and those who have been trying for years to get a reservation.

"This is primarily a European type of sport," said Nelson, "We're very unique and nobody else has really caught on."

The 2-1/2-hour experience costs \$50 per person and includes sled, helmet, luge sledding instruction, open air snowcat ride up Bear Mountain, and guided sledding down five-plus

Manson The current of Commerce Chamber originally began as the Manson



3. If you have kidney problems, avoid getting extra magnesium.

4. Change up your laxatives. If you need a laxative regularly, avoid magnesium.

5. Don't mix magnesium with antibiotics.

Avoid taking magnesium between 1 hour before and at least 2 hours after certain antibiotics. Magnesium and other minerals like iron and calcium will attach directly to certain antibiotics, preventing you from absorbing the entire dose.
