Congresswoman Kim Schrier celebrates \$660,000 Federal Fund for Chelan County Sheriff's Office

WENATCHEE - In a press event held on June 7 in front of the Chelan County Superior Court, Congresswoman Kim Schrier (D-WA) announced a substantial federal investment of \$660,000 aimed at bolstering the Chelan County Sheriff's Office. The Washington State representative expressed her optimism that the funds will contribute to increased transparency within the department while simultaneously improving safety measures for law enforcement officers.

The focus of this successfully funded project is to equip the Chelan County Sheriff's Office with the technology, training, and resources needed to facilitate the full use of body cameras by law enforcement officers.

"Body cameras are more than just pieces of technology," Chelan County Sheriff Mike Morrison said about his enthusiasm for this investment in police accountability. "They are instruments of transparency and trust. Body cameras ensure that everyone is held accountable for their actions, including us in uniform."

Douglas County Sheriff Kevin W. Morris attended the event with the Axon body-worn camera system that will most likely be used by the Chelan County Sheriff's Office, demonstrating its functions and capabilities. With his help, Rep. Schrier was able to quickly equip a body-worn camera and display its live feed feature, which could be used by law enforcement to better understand situations as they unfold.

Rep. Schrier emphasized a heavy focus not just on accountability but on community safety, saying, "one of the additional benefits of body cameras is that, when you have that [body camera] on, it is a tool in de-escalating because people do not want to behave badly.' Schrier added, "everyone deserves to feel safe in their communities...and so I want everyone to feel safe and body

cameras are a part of that." Congresswoman Schrier helped secure this sizable federal investment through Community Project Funding (CPF), a federal grant program part of the US Department of Housing and Urban Development's Economic Development Initiative. Within the US House of Representatives, CPF allows representatives to request funding for specific projects in their district, ensuring a direct pipeline of funds moving from the federal government into local communities.

Rep. Schrier explained the impressive efficiency of this Community Project funding, "this is a way for us to not have money go through the state, through a long bureaucracy to get to projects, but to go straight to what matters most to the community,'

According to Sheriff Morrison, "it will take a couple of months to get [Chelan County Sheriff's Office] up and running as we go through." But, once the training and resources are in full effect, Morrison seeks to "release photos and video from our instruments that our deputies are handling in order to show the community what

Tickets on sale for Leavenworth Summer Theater's 30th anniversary season

LEAVENWORTH - General public and group tickets are now on sale for Leavenworth Summer Theater's (LST) 30th anniversary season. This summer will feature Disney's "Beauty and the Beast" and renowned "The Sound of Music" at Ski Hill Amphitheater.

"Beauty and the Beast" will be directed by Tiffany Mausser. The original Broadway production ran for thirteen years and was nominated for nine Tony Awards.

"It's a rare opportunity, as Disney has put the show "back in the vault" for years. We were fortunate to secure one of the final licenses, making us one of the last companies in the Pacific Northwest to offer this special show for the foreseeable future," said LST Executive Director Christy Shearer.

"The Sound of Music" will see the return of Autumn Manson, from Redlands, CA, taking on the role of Maria. Ernest Palmer will return for his sixth year as Captain von Trapp. The von Trapp children will be played by 14 local and regional youth.

"This year, over 300 actors competed for 50 spots. Most actors are in both productions, changing characters from day

to day. It's a huge challenge!" said Shearer.

Shearer describes each production as a "year-long labor of love," with over 100 volunteers and professionals contributing each year. The productions feature both local talent and performers from across the country, as well two live orchestras consisting of musicians from all over Washington State.The shows are selected a year in advance, and preparation starts right as summer productions end. LST works on set and costume design in the fall, and begins

casting by February.

Three decades in, the summer theater is bolstered by the support of schools, staff, actors, musicians, technicians, volunteers, and donors throughout the community. It garners approximately 500 visitors to each of its performances every summer.

"Over our 30-year history, we've had over 350 von Trapps grace our stage, witnessed LST marriages, and now welcome a second generation of LST kids. That's the most rewarding aspect of what we do. We even had a real von Trapp family

member attend a performance in 2022!" said Shearer.

However, the theater didn't start as a success. In fact, the co-founders weren't sure if it would survive a second year after a disastrous first summer in 1994

The story of LST dates back to the 1980s, when actors Bill Weis and John Wagner became friends through the Coeur d'Alene Summer Theatre in Idaho.

"At one point, John mentioned his desire to start a semi-professional summer theater to Bill, and Bill surprisingly and generously offered to fund it," said Susan Wagner, LST co-founder and wife to John.

After researching various locations across Idaho and Washington, the founders chose Leavenworth to launch their theater. The Wagners would move their family out to the Bavarian town to start production. In addition to financing the first year, Weis and his wife, Marilyn Roy, would help with administrative tasks.

In 1994, the Wagners opened LST with a summer production of Hansel and Gretel. The show was low in popularity, and ended in several weeks of cancellations due to nearby fires.

"Ticket sales and audience numbers were low, and at the end of the summer, we had lost all of the money that Bill had

put into the theater. However, Bill encouraged us to try one more year, and said he would finance it again," said Susan.

of Music."

In 1995, they tried "The Sound of Music," and the theater took off. The last show of the 1995 season attracted over 800 audience members, which was the largest show in LST history. Since then, the theater has switched to reserved seating, added and changed locations, and has produced over 50 different shows in its 30 years. However, "The Sound of Music" has remained a staple production every summer.

"It has been the mainstay of our continued success and longevity," said Susan.

Condominium allowance to head to City Council

LEAVENWORTH - Following a varied public hearing, the Planning Commission moved to approve its proposed code amendments for condominium within ownership Residential zoning districts during its June 7 meeting. The Planning Commission's recommendations ultimately go before City Council for deliberation and a vote.

The largest topic of concern was whether protections would be put in place for renters who may be affected by the condominiumization of their unit, with some skeptics proposing a relocation program for low-income tenants.

"I don't believe that it's in the city's best interest to create such a program, because it would be expensive, and I don't think it would be utilized. It's unusual for me to share an opinion like that, but I think it's important on this particular topic," said Community Development Director Lilith Vespier.

Vespier added that the likelihood of renters being displaced is quite low, due to that fact that many existing dwellings would be disqualified from converting based on the requirements, and that most renters would not qualify for low-income assistance, which RCW 59.18.440 defines as at or below 50 percent of the average median income (AMI).

Planning Commissioner Allison Miller reinforced

this opinion, adding that the conversion would be no different than a house that is currently rented going up

Skinnarland, Kirvil representing Residents Coalition of Chelan County (RC3), was supportive of the condominium idea, but wanted to ensure tenant protections.

"Even though it's a low probability according to what Lilith says based on her knowledge of the town, we still feel like relocation assistance of some type should be available and the city could possibly contract out for that," said Kirvil Skinnarland, representing Residents Coalition of Chelan County (RC3).

City Councilmember Zeke Reister testified with similar sentiments as RC3. However. Vespier told Reister that it was inappropriate for him to speak as a council member at the Planning Commission's public hearing.

"This is going to be coming before you and you will have the final say on the decision. This time is provided for the Planning Commission to [form] a recommendation to your body," said Vespier. "I find it's challenging to help Planning Commissions remain impartial and not sway them."

The Planning Commission voted to approve the recommendations, with Commissioner Planning Janessa Ruckle abstaining.

our deputies are doing... the community really should see what they're getting back in return."

Through programs like CPF, Rep. Schrier has already secured direct federal funding for other important community projects, such as local food banks, school-based health clinics, and improvements to a local senior center.

'We get somewhere between

10 and 15 projects a year... and there are certain ones that rise to the top, and clearly this is one of them," commented Rep. Schrier about the importance of protecting the community through better documentation and police accountability.

Chelan County Commissioner Shon Smith closed out the event with an optimistic attitude toward the implementation of body cameras, stating, "They may decrease the use of force in incidents... and they may even prevent an already dangerous situation from escalating." Smith looked to the future, concluding, "I hope to see this new program enhance the reputation of Chelan County Sheriff's Office as a leader in the community policing in our region. And I hope to see that it also makes our streets safer for our citizens and the community overall."

their response to a dangerous situation.

"These four individuals were vital to the safety and peaceful resolution of an inherently dangerous situation involving a combat veteran who had expressed suicidal ideations and consumed pills and alcohol, a dangerous mix," Morrison said.

"The team arrived on scene and began to reach out and attempt to get the individual much-needed help through the use of de-escalation tactics and Jose's behavioral health expertise," he said. "Ultimately, they were able to detain the individual without incident, get him to the professionals who could help him, and ensured that night was not his last."

Deputies Tristen Jurgensen and Brian Bender received Life Saving Awards for their quick response in a case where a juvenile had severely

cut their arm after breaking windows. The deputies used their first aid training to apply tourniquets and pressure to the wound to stop the intense bleeding until medical teams arrived on the scene.

Deputy Anders Wiggum received a Life Saving Award for his response to a collision involving major injuries.

"Being the first on scene. he quickly began to assess the patients as best as he could and coordinating responses from multiple first responder agencies," Morrison said. "His actions and quick thinking were vital to the involved parties getting the care they needed when they needed it."

Meritorious Conduct award recipients were Sgt. Rob Huddleston, Deputy Carlos Rodriguez, Mike Battis with Ballard Ambulance, Campus Security Deputy Elgin Shaw, and Detective Brett Peterson.



(c) All buildings, structures, improvements, fixtures and property now or hereafter attached to or used in the operation of the Property (d) All rents, issues and profits of the Property, all existing and future

leases of the Property (including extensions, renewals and subleases), all agreements for use and occupancy of the Property (all such leases and agreements whether written or oral, are hereafter referred to as the "Leases"), and all quaranties of lessees' performance under the Leases. together with the immediate and continuing right to collect and receive all of the rents, income, receipts, revenues, issues, profits and other income of any nature now or hereafter due (including any income of any nature coming due during any redemption period) under the Leases or from or arising out of the Property including minimum rents, additional rents. percentage rents, parking or common area maintenance contributions, tax and insurance contributions, deficiency rents, liquidated damages following default in any Lease, all proceeds payable under any policy of insurance covering loss of rents resulting from untenantability caused by destruction or damage to the Property, all proceeds payable as a result of a lessee's exercise of an option to purchase the Property, all proceeds derived from the termination or rejection of any Lease in a bankruptcy or other insolvency proceeding, and all proceeds from any right and claims of any kind which Grantor may have against any lessee under the Leases or any occupants of the Property (all of the above are hereafter collectively referred to as the "Rents"). This subsection is subject to the right, power and authority given to the Beneficiary in the Loan Documents (as defined herein) to collect and apply the Rents.

(e) All compensation, awards, damages, rights of action and proceeds (including insurance proceeds and any interest on any of the foregoing) arising out of or relating to a taking or damaging of the Property by reason of any public or private improvement, condemnation proceeding (including change of grade), fire, earthquake or other casualty, injury or decrease in the value of the Property; all returned premiums or other payments on any insurance policies pertaining to the Property and any refunds or rebates of taxes or assessments on the Property.

(f) All permits, permit applications, plans, specifications, contracts, agreements and purchase orders pertaining or incidental to the design, construction, maintenance or management of any improvements on the Property, Grantor's rights under any payment, performance, or other bond in connection with construction of improvements on the Property, and all construction materials, supplies, and equipment delivered to the Property or intended to be used in connection with the construction of improvements on the Property wherever actually located.





If Valdez were to give one


piece of advice to incoming freshmen, it would be to make sure they have a well-rounded life throughout high school.
