Chelan council workshop considers AI network to improve community engagement

CHELAN - The city is on the cusp of joining the artificial intelligence (AI) revolution by upgrading its ability to interface with its citizens through a new research platform called Thought Exchange. The hightech tool was the opening topic of the city council's regular monthly workshop held on June 4.

"One of the priorities for the city this year is to get more engagement from our community on the things that we do," said Mayor Erin Mc-

Up to this point a program called Survey Monkey, an online tool used to create surveys, polls, and quizzes, has been the city's principal platform

"It is basic and time consuming unless you are doing just straight multiple-choice questions," said McCardle. "It does not open up the doors to allow any conversations to

The city learned of Thought Exchange from the school district that and bond information with the public and get useful responses in return.

"In this day and age, we have a lot of tools available with AI to make it easier for us to go out to the community and get their feedback in a meaningful way," McCardle said. "This is important because we have a major comp plan update coming up that is the foundation of our planning effort."

McCardle used early data from the very beginning ofthe Imagine Downtown project to allow Thought Exchange to demonstrate what it can do

with informationfamiliar to council members.

The platform emphasized its ability to capture the voice of people by utilizing three modes of listening:

• Qualitative data collection.

· Digital one-to-one interviews with interactive two-way conversations.

Create, monitor, and benchmark a strategic plan. A Thought Exchange representa-

tive imported 1,100 responses provided by McCardleand showed how a first level word cloud analysis filtered and refined responses on topics such as

parking, traffic, safety, accessibility, outdoor dining, public amenities, and more. Further filtering transformed a "collective mess" of data into increasingly specific detail according tothe user's needs. Following further demonstrations showing the variety of options available to granulate and interact with the survey responses McCardle said Thought Exchange will be included for consideration on the upcoming council agenda.

CHELAN - The City of Chelan announced Tuesday the launch of the Lake Chelan Vision Project, a community-driven initiative aimed at identifying core values and establishing a foundation for future planning efforts in the Lake Chelan Valley.

The project, the first of its kind in the area since 2006, will involve outreach to residents from Twenty-Five Mile Creek to South Shore, Chelan, Union Valley, and Manson. A bilingual community survey is now available in English at www.surveymonkey.com/r/ LCVP and in Spanish at www.surveymonkey.com/r/LCVPSpan. Seven listening sessions will be scheduled in the coming weeks.

"The Lake Chelan Valley will continue to grow," said Chelan Mayor Erin McCardle. "We must take bold actions now to address the challenges as well as opportunities we are facing if we want to preserve the qualities of living in a small rural community.'

has been retained to conduct outreach and visioning activities, collect and analyze input from community members, and draft an initial set of core community values.

A project management team, consisting of local leaders and representatives, will oversee the initiative to ensure the integrity and validity of project outcomes.

To date, 20 local organizations are assisting the project, including the Lake Chelan Chamber of Commerce, Lake Chelan School District, and various community groups.

The City of Chelan sees this outreach and visioning work as an essential investment in community building, with the goal of creating a more cohesive, connected, and inclusive com-

Congresswoman Kim Schrier celebrates \$660,000 Federal Fund for Chelan County Sheriff's Office

WENATCHEE - In a press event held on June 7 in front of the Chelan County Superior Court, Congresswoman Kim Schrier (D-WA) announced a substantial federal investment of \$660,000 aimed at bolstering the Chelan County Sheriff's Office.

The Washington State representative expressed her optimism that the funds will contribute to increased transparency within the department while simultaneously improving safety measures for law enforcement officers.

The focus of this successfully funded project is to equip the Chelan County Sheriff's Office with the technology, training, and resources needed to facilitate the full use of body cameras by law enforcement

"Body cameras are more than just

pieces of technology," Chelan County Sheriff Mike Morrison said about his enthusiasm for this investment in police accountability.

"They are instruments of trans-

parency and trust. Body cameras ensure that everyone is held accountable for their actions, including us in uniform.' Douglas County Sheriff Kevin W.

Morris attended the event with the Axon body-worn camera system that will most likely be used by the Chelan County Sheriff's Office, demonstrating its functions and capabilities. With his help, Rep. Schrier was

able to quickly equip a body-worn camera and display its live feed feature, which could be used by law enforcement to better understand situations as they unfold.

Rep. Schrier emphasized a heavy focus not just on accountability but on community safety, saying, "one of the additional benefits of body

cameras is that, when you have that [body camera] on, it is a tool in de-escalating because people do not want to behave badly." Schrier added, "everyone deserves to feel safe in their communities... and so I want everyone to feel safe and body cameras are a part of that."

Congresswoman Schrier helped secure this sizable federal investment through Community Project Funding (CPF), a federal grant program part of the US Department of Housing and Urban Development's Economic Development Initiative.

Within the US House of Representatives, CPF allows representatives to request funding for specific projects in their district, ensuring a direct pipeline of funds moving from the federal government into local communities.

WENATCHEE - The Chelan County Sheriff's Office recently recognized employees for outstanding service.

"Congratulations to all the winners of our region's recent award ceremony," Sheriff Mike Morrison said. "The dedication and contributions uplift our communities and inspire us all to strive for excellence."

Deputy Andrew Tilton was awarded Deputy of the Year.

"Deputy Tilton was recognized by his immediate supervisors as one who continually works hard to achieve the mission of the Office through all aspects of his assigned duties and responsibilities," Morrison said. "His dedication to the team, outstanding work ethic, and produced results reflect great credit upon himself, his squad, and the Chelan County

Sheriff's Office." Jillian Simmons awarded Support Staff of the Year for her work at the Sheriff's Office.

"Jillian represents the office in a positive light each and every day and excels in all of her assigned duties and responsibilities," Morrison said.

Vernon Nelson Jr. earned Volunteer of the Year for his work with the Chelan County Mountain Rescue.

"The Chelan County Sheriff's Office takes immense pride in announcing Vernon Nelson Jr. as the recipient of the prestigious Chelan County Sheriff's Office Volunteer of the Year award," Morrison said. "As the Sheriff of Chelan County, I have personally witnessed Vernon exemplifying the very essence of dedication, expertise, and unwavering commitment to saving lives in the most challenging terrains imaginable."



Deputy Anders Wiggum received a Life Saving Award for his response to a collision involving major injuries.

"In the rugged expanse of Chelan County, where the backcountry poses formidable challenges, Vernon has stood as a beacon of hope and resilience," he said.

"While the Sheriff's Office bears the legal mandate of backcountry rescue, it's Vernon and his team of mountain rescuers who often navigate the most treacherous paths to answer the call of those in dire need. The Chelan County Sheriff's Office and the citizens served are deeply indebted to Vernon's unwavering commitment to the welfare

Andrew Tilton, Cy Bowthorpe, Jeremy Mannin, Jose Hernandez received Life Saving Awards for their response to a dangerous situation.

"These four individuals were vital to the safety and peaceful resolution of an inherently dangerous situation involving a combat veteran who had expressed suicidal ideations and consumed pills and alcohol, a dangerous mix," Morrison said.

"The team arrived on scene and began to reach out and attempt to get the individual much-needed help through the use of de-escalation tactics and Jose's behavioral health expertise," he said.

"Ultimately, they were able to detain the individual without incident, get him to the professionals who could help him, and ensured that night was not his last."

Deputies Tristen Jurgensen and Brian Bender received Life Saving Awards for their quick response in a case where a juvenile had severely cut their arm after breaking windows. The deputies used their first aid training to apply tourniquets and pressure to the wound to stop the intense bleeding until medical teams arrived on the scene.

Deputy Anders Wiggum received a Life Saving Award for his response to a collision involving major injuries.

"Being the first on scene, he quickly began to assess the patients as best as he could and coordinating responses from multiple first responder

agencies," Morrison said. "His actions and quick thinking were vital to the involved parties getting the care they needed when they needed it."

Rep. Schrier explained the impressive efficiency of this Community Project funding, "this is a way for us to not have money go through the state, through a long bureaucracy to get to projects, but to go straight to what matters most to the community,"

According to Sheriff Morrison, "it will take a couple of months to get [Chelan County Sheriff's Office] up and running as we go through."

But, once the training and resources are in full effect, Morrison seeks to "release photos and video from our instruments that our deputies are handling in order to show

the community what our deputies are doing... the community really should see what they're getting back in return."

Through programs like CPF, Rep. Schrier has already secured direct federal funding for other important community projects, such as local food banks, school-based health clinics, and improvements to a local senior center.

"We get somewhere between 10 and 15 projects a year... and there are certain ones that rise to the top, and clearly this is one of them," commented Rep. Schrier about the importance of protecting the community through better documentation and police accountability.

Chelan County Commissioner Shon Smith closed out the event with an optimistic attitude toward the implementation of body cameras, stating, "They may decrease the use of force in incidents... and they may even prevent an already dangerous situation from escalating.'

Smith looked to the future, concluding, "I hope to see this new program enhance the reputation of Chelan County Sheriff's Office as a leader in the community policing in our region. And I hope to see that it also makes our streets safer for our citizens and the com-

Chelan County Sheriff's Office receives \$49,100 grant for officer wellness

WENATCHEE - The Chelan County Sheriff's Office Behavioral Health Unit (BHU) has been awarded a \$49,100 grant from the Washington State Criminal Justice Training Commission (WACJTC) for the fiscal year July 2024 through June 2025, Sheriff Mike Morrison announced Monday.

The grant will fund peer support and critical incident stress management training, neurofeedback machines, PTSD workshops for law enforcement and their spouses, and continuing education materials.

This marks the second consecutive year the WACJTC has awarded the Officer Wellness grant to Chelan County.

BHU Program Manager and Licensed Mental Health Counselor Ana Gonzalez has been credited with securing over \$1.9 million in grants over the past two years, with \$268,578 allocated to officer wellness and \$1.7 million supporting the BHU's initiatives.

The BHU, a co-responder program that partners mental health professionals and case managers with law enforcement, aims to divert individuals with behavioral health challenges from the criminal justice and emergency medical systems by providing crisis response and connecting them to appropriate community resources.

Almost \$900,000 secured for mobile water tanks to boost rural firefighting in Chelan County

LEAVENWORTH - Congresswoman Kim Schrier secured nearly \$900,000 in federal funding to place 12 mobile water tanks across Chelan County in order to bolster firefighting capabilities in rural areas.

The project will install 21,000 gallon water tanks in wildfireprone locations that are far from existing hydrants, in order to fight fires more efficiently and aggressively. The project has the potential to better protect rural neighborhoods, and may even help secure or even lower home insurance rates.

"It has a really big impact not only on people's physical safety and security, but also on their nest egg, and whether they will be able to fund the rest of their lives," said Congresswoman

Currently, departments use a water tender, or a vehicle designed to carry water, to transport approximately 2,000 gallons of water to a scene. With one tank, a water tender could save nearly ten critical refill trips. When it runs out, a fire along Chumstick Highway could take upwards of 45 minutes for a water tender to drive to the nearest hydrant, refill, and return to the fire.

"That time is when firefighters can lose fires," said FD #3 Chief Kelly O'Brien.

At least half of the water tanks will be placed in the Upper Valley, primarily along the Chumstick Corridor. Others will be placed in Manson, Chelan, Entiat, and Malaga.

"I'm really excited because what we're doing here is going to be able to be replicated, and not just in other places in Washington State. This can be replicated in rural communities

across the country," said Ron Cridlebaugh, Chelan County Economic Services Director.

According to Cridlebaugh, the next steps will be to identify the exact location for the tanks,

and regulatory compliance. The county expects to install its first tank before the 2025 wildfire season, likely along Chumstick Highway.

"As soon as one is done, we'll be working on the next," said Cridlebaugh.

The water tanks, which look like shipping containers, will have the ability to be installed either above or below ground, and will be insulated on the exterior for a rating to -10 degrees.

Chelan County estimates the cost of the project will be \$1.2 million for the initial 12 water tanks, and will add more as additional funding is secured. The project will utilize the \$893,250 secured by Congresswoman Schrier, as well as \$50,000 Chelan County PUD committed to the project.

Chelan PUD expands wildfire prevention plan, introduces county-wide power shutoff strategy

WENATCHEE – In an effort to prevent wildfires and increase fire resilience, Chelan County Public Utility District (PUD) announced the expansion of its comprehensive wildfire mitigation plan, which now includes a county-wide strategy for proactively turning off power during extreme weather

The expanded plan, called fire safety outage management, is a measure of last resort and will be implemented in fireprone areas throughout Chelan

This move comes after the successful pilot of a similar plan in 2021, which covered about 3,000 customers in the Lake Wenatchee/Plain area.

Chelan PUD's wildfire mitigation plan also includes vegetation management, fire hardening of transmission structures, and equipment upgrades in high-risk areas.

The utility has been using fire risk assessments to guide these place-based measures.

Throughout the summer, Chelan PUD will closely monitor weather forecasts, including wind gusts, humidity, fuel moisture, and potential fire behavior. If a fire safety outage becomes necessary, the utility will attempt to notify customers 48 hours in advance

through various channels, including email, phone messages, media, and partner organizations.

General Manager Kirk Hudson emphasized the importance of a robust wildfire mitigation plan, stating, "It's prudent that we put a robust wildfire mitigation plan in

place to protect our communities from weather events, forest conditions and legal risks."

Chelan PUD encourages customers to prepare for potential fire safety outages by updating their contact information, signing up for emergency notifications, creating an emergency plan, and considering backup power options for critical needs. The utility also maintains an Electrical Medical Needs Registry for those who rely on electricity for medical equipment.

PREPARING FOR A FIRE **SAFETY OUTAGE**

As Chelan PUD expands its fire safety outage management plan county-wide, residents are encouraged to take the following steps to prepare for potential power shutoffs:

Ensure your contact infor-1. mation is up to date with Chelan PUD by visiting chelanpud.org/updateyourinfo. This will allow the utility to notify you promptly in case of a planned outage.

2. Sign up for Everbridge emergency notifications through Chelan County Emergency Management to stay informed about local emergencies and updates. • Create an emergency plan **o** and stock up on essentials

such as water, non-perishable food, cash, and medications to sustain you and your family during an extended outage. 4 Consider investing in a backup generator to power

critical equipment like well pumps or refrigerators during a prolonged outage. If you rely on electricity 5. If you rely on electricity to operate medical equipment, make sure to sign up

for the Electrical Medical Needs Registry at chelanpud.org/ medform to ensure the utility is aware of your specific needs. Vulnerable individuals may also consider joining

a registry through Chelan County Emergency Management to receive additional support during emergencies.

By taking these proactive steps, residents can help ensure their safety and well-being during a fire safety outage.

Stopping a Nosebleed

Q: Last week, I got a nosebleed that wouldn't stop. In the Emergency Room, the doctor shoved gauze up my nose. It hurt so bad I NEVER want that done to me ever again. How can I stop a nosebleed on my own?



Your nose has two sets of

blood vessels: one in front of the bony part of your nose, called the anterior blood vessels, and another inside and beyond your nasal bone, called the posterior blood vessels. Luckily, 90% of nosebleeds are from the anterior blood vessels and can be stopped using direct pressure, usually by pinching

your nose shut. Stopping a nose-

bleed from your posterior blood

vessels is much more challeng-

ing because you can't press on them directly. Your nasal bone protects them. Nosebleeds are more common in dry climates like Eastern Washington and during the winter, as your air loses moisture from using a furnace or wood stove daily. Using oxygen dries out the tissues surrounding the blood vessels that line your nose, making them more fragile

and likely to bleed. Applying an ointment or gel to your nostril with a Q-tip every night helps prevent nosebleeds by keeping the inside of your nose moist. If you wear oxygen tubing with prongs that extend into your nostrils, avoid using Vaseline® or petroleum jellybased ointments because they can dissolve the plastic tubing.

Instead, use a saline nasal gel,

like Ayr®. Nosebleeds are also more likely if you take a blood thinner. Taking a blood thinner medicine like aspirin, clopidogrel (Plavix®), Eliquis®, Xarelto®, Pradaxa®, and warfarin (Coumadin®) can increase the frequency and sever-

ity of nosebleeds. Using nose sprays for allergies like Flonase®, Nasacort®, or Nasonex® can also cause nosebleeds. To reduce nosebleeds, always point the nozzle of the nasal spray away from the tissue that separates your nostrils, called the septum. If you get a nosebleed, apply

direct pressure by leaning forward and pinching your nose shut. Leaning forward instead of backward puts more pressure on blood vessels. It keeps you from swallowing blood, which can cause nausea and vomiting, which can aggravate the bleed-

Keeping your nose pinched shut for 10-15 minutes without letting up on the pressure is most effective. Inserting a rolled piece of gauze or cotton into your nostril as a plug will also help slow bleeding. In addition to gauze and direct

help stop bleeding are available

quickly, helping to control bleeding. Oxymetazoline (Afrin®) nasal spray is inexpensive and available without a prescription. Some non-prescription prod-

ucts control bleeding by jumpstarting the clotting process. Oxidized cellulose is derived from plants and has been used to stop bleeding in surgery since the 1960s. It is available over the counter in several forms, includ-

ing spray powder, small gauze

squares, impregnated bandages,

and gauze dressings. Curad®

Quick Stop and Quick Seal® contain oxidized cellulose. Chitosan (Celox®) is derived from shells. Widely used by the military, Celox® is available as granules in 2-gram packets for sprinkling on wounds and incorporated into large flat bandages

and nosebleed dressings. Calcium alginate is extracted from brown algae. It's very absorbent and stops bleeding by releasing calcium when in contact with blood. When blood contacts it, it transforms into a gel and jumpstarts the clotting process. Calcium alginate is available as

Avoid using products containing kaolin, like QuickClot®. It is clay-like and can be difficult to remove from wounds.

Here are 5 Tips for Dealing

with a Nosebleed:

Nasal Cease® or Bleed Cease®

Lean forward while pinch-. • ing your nostrils shut. Hold direct pressure for at least 10-15 minutes before letting up. Avoid

swallowing blood if you can. 2. Try AITH (UA) HELD and sprays of Try Afrin® (oxymetazoa tight plug, add two sprays of Afrin®, insert into your nostril, then pinch it closed.

Try a blood-clotting nose-•bleed product. Try gauze pads or pre-formed plugs impregnated with blood-stopping agents like calcium alginate (NasalCease®), oxidized cellulose (Curad® Quick Stop), or chitosan (Celox®).

Get medical attention if 4 needed. If blood runs down your throat even while leaning forward or you're still bleeding despite applying direct pressure for at least 10-15 minutes, you could have a posterior nosebleed, which is very hard to stop. Seek medical attention.

Chelan Community Center enters partnership with Boys & Girls Clubs of **Snohomish County**

CHELAN - The city took a giant step forward on behalf of its youth last week with the announcement that a Boys and Girls Club will take up residence at the Lake Chelan Community Center. City Administrator Wade Farris introduced Community Center Executive Director Maribel Cruz who broke the news at the regular monthly meeting of the Chelan City

Council Workshop on June 4. "We are very excited to announce that we have secured a partnership with the Boys & Girls Clubs (BBGC)," said Cruz. "Last month we signed a 15-year

lease with the BBGC.' The Community Center has prepared a spot for its new partner.

"They will be taking about 7,000 sq. ft of upstairs dedicated space at the Community Center," said Cruz."Once we finish off the gym there will be BBGC activities there as well.'

Cruz views the BBGC addition as a good fit.

"We have invited the BBGC to be apart of the community center because we really felt that at the heart of what the community center is trying to do is to wrap our arms around the youth and also those who can't necessarily pay for services or who are underserved," said Cruz. "If we can help them, that helps everybody.

Executive Director Bill Tsou-

kalas explained that there are 1,000 organizations like Snohomish County in the Boys & Girls Club world that represent about 4,000 individual locations.

BBGC of Snohomish County currently have 26 locations spread across a multi-county area not just Snohomish County, said Tsoukalas. Eight are on reservations. There are other organizations in Spokane, Colville, Tri-Cities, and Moses Lake. There remains a vacuum in Eastern Washington from Yakima north to Wenatchee. Chelan, and on to the border.

Tsoukalas explained that it is much easier and a less expensive pathway to start within an existing club rather than start your own 501(c)(3). "We have a presence in

Eastern Washington at Brewster

and three clubs on the Colville Confederated Tribes Reservation," said Tsoukalas. The Brewster BBGC started in 2016 and serves more than 400 youth in the greater Brewster area. Clubs are also located



Through church, she's taken on leadership roles and been involved with service projects, such as Adopt a Grandma, in which the youth choose an elder woman to serve in various ways.


"We made them bracelets, we took them their favorite dessert, and we sent them letters. We even had a tea party at the end," said England.

CHELAN – Chelan High School salutatorian Benjamin Brownfield was motivated to strive for academic excellence by his career goals and by a family history of academic achievement.

"I've always been academically motivated, but my biggest motivation has been to prepare myself for my career," he said. "I want to become an automotive engineer, and this is a very competitive field. I need to make my resume as impressive as possible to set myself up for success."

"Another motivator for me has been my family," he said. "My dad was the valedictorian for CHS in 1984, and my grandpa was Chelan's valedictorian in 1958. My family never made me feel pressured, but they always supported me and encouraged me to be a good student."

Brownfield said the most influential people in his life are his parents. They help him manage his busy schedule and help him

whenever he needs it.

"My mom used to be an elementary school teacher, and without her, I never would've had the solid foundation I needed to start my education," he said. "I wasn't a very strong reader when I first started going to school, but she got me on track and gave me a passion for reading."

"My dad is very knowledgeable about almost everything, and he is what started my interest in automotive engineering," Brownfield said. "When I was little, he would explain different systems and components in cars, compressors, chainsaws, and everything else in an orchard. He answered countless questions and would even look up things he didn't have answers to and answer them later."

Brownfield was born and raised in Chelan and grew up on his family's organic fruit orchard, Brownfield Orchard. They grow apples, pears, peaches, cherries, apricots and more. His family has been growing fruit in the Chelan area

for six generations.

He has been taking high school classes since 7th grade and hasn't let up since. He took 13 college or AP classes during high school and is very proud of the effort he put into all of them, he said.

"I would say I am most proud of being salutatorian because it sums up all of the work I have put into high school," he said.

The biggest challenge Brownfield faced in high school was online schooling during the COVID-19 pandemic. COVID started during his eighth-grade year, and he started freshman year completely online.

"Online learning really didn't fit my learning style, and I got my only A- that year," he said. "Then the next year was a huge adjustment as we were back to full school days, and teachers were giving the same amount of work they had given before covid. While I did get used to the new workload, it was a struggle at first"

Brownfield is co-president of Chelan Project, an outdoor adventure and community service club, which is the biggest club in the school.

"This club has really changed me as a leader and has taught me how to better collaborate with other leaders," he said.

His other clubs include National Honors Society, Med Club, and Knowledge Bowl. Senior year he played tennis and ran cross country. He also played football, basketball, and track during high school.

"From these, I learned how to be a team player and how to push myself physically," he said.

Band was a huge part of his time in high school. He was a percussionist in concert band, played drumset for pep band and Toms for marching band. He was the drummer for jazz band and a percussionist in Valley Winds, a community concert band. He also helped the music teacher, Mr. Burdick, teach the 5th grade percussionists and clarinets.

"Mr. Burdick was my band teacher, and he's been teaching me since 5th grade," he said. "He is an excellent person and has been a great example to me."

"Mr. Bovingdon and Mr. Gleasemen were my English

"My dream job would be developing powertrains for Formula 1 cars," he said. "The average internal combustion engine is only 30% thermally efficient, which means lots of the energy from the fuel is being wasted as heat. Formula 1 cars are nearly 50% thermally efficient, which is a much higher number."

"Technology from F1 often makes its way to commercial cars we drive," he said. "I think it would be an amazing job to be at the forefront of making engines more efficient, while also working with high-performance machines."
