Chelan County seeks public's help in locating stolen traffic safety signs

CASHMERE — Chelan County Public Works (CCPW) is seeking the public's help in locating seven stolen traffic safety signs in the Cashmere area. The signs, which warn motorists of loose gravel and advise motorcyclists to use extreme caution, are crucial for maintaining safety during the ongoing chipsealing work in the region.

In a statement released on June 6, CCPW urged locals to report any suspicious activity, stating, "We are asking the public to contact us if you see anything suspicious. We believe the same person is messing with these steel signs. If you see the signs laying around, we'll come pick them up.'

The theft of these signs poses a significant risk to motorists, county workers, and pedestrians, as they serve to alert road users of potentially life-threatening hazards. We just want it to stop because these signs are used for the public's safety. We take that very seriously," CCPW emphasized in their public statement.

The missing signs were noticed as CCPW began their annual chipsealing work on Ranch Road and Camas Creek Road, part of a county-wide preservation program

aimed at protecting roads and traffic infrastructure from the damaging effects of snow and ice. Additionally, the department is preparing for a month-long closure of the Peshastin Bridge starting this week to replace critical joints and add a new concrete overlay.

Ryan Moody, Chief of Special Operations at Chelan County Sheriff's Office, stated that they "haven't received any further updates on the

issue," suggesting that no additional disturbances have been reported in connection with the thefts.

Peshastin Library dances through renovation with free Folkloric Classes and **Community Programs**

PESHASTIN - Despite the temporary closure of its building for renovations since April, the Peshastin Library is bringing the community together through a series of free, Mexican folkloric dance classes for local youth this summer.

The classes, designed for children ages 8-12, will be held at the Peshastin Dryden Elementary School gym on Tuesdays from 5-6pm and Thursdays from 11am-12pm. The instructor, Sandy Zárate, is a certified dance instructor and owner of the Sanzar Dance Company, where she teaches bilingual classes.

Librarian Clare Morrison expressed her enthusiasm for the library's first long-term instructional series. "I'm really, really excited that we're going to be able to offer this kind of longer term series and have a community performance at the end. [It's] kind of a unique thing that we don't often offer at the library," Morrison said.

Zárate, who grew up and studied in Oaxaca, Mexico, has a lifelong passion for dancing. She has performed in the state's largest festival, La Guelaguetza, and now dedicates her time to promoting a deeper understanding of art and culture through dance. Her goal is to help future generations of youth appreciate the beauty and richness of Mexican folklore.

activities, both virtually and physically, thanks to the support of PD Elementary's library and gymnasium. In addition to the dance classes, the library has been organizing various programs during the renovation period.

One such program is the weekly ukulele circle, which takes place at the PD Elementary library each Wednesday at 5:30pm. The circle welcomes locals of all ages and skill levels to strum along to provided music packets together. "It's a really great group of folks and we're always open to new members as well, at all different levels," Morrison said, describing the program with excitement.

CASHMERE - Cashmere High School seniors voted science teacher Jeff Kenoyer the 2024 Theo Allen Teacher of The Year.

CHS senior and class vice president Daniela Reyna announced the award at the senior recognition night.

"The Theo Allen Teacher Of The Year is a special teacher that our class is especially close to," Reyna said in her speech. "He has taught almost 40 years all here at Cashmere, has the funniest dry sense of humor you can ever imagine, and has coached most of us at one point or another."

"We know he cares for all of us deeply but keeps that professional distance that allows for that air of respect and professionalism that we all have become very comfortable with," Reyna said.

"Throughout his career, he has head-coached two sports per year," Reyna said. "And at times, he has coached three sports in a year. He just completed a very successful track season. We would like to honor Mr. Jeff Kenoyer with the Theo Allen Teacher of the Year award."

Fellow CHS teacher Karin Blomquist said Kenoyer has been teaching for 38 years at Cashmere, one more year than her.

Kenoyer started as a middle school science teacher and then moved to the high school after the high school

science teacher retired. Blomquist said that he coaches two sports every year, which is a daunting task.

Kenover coaches cross country in the fall and track in the spring. Sometimes, he even coaches basketball in the winter, making him a three-sport coach.

"The kids just love him," Blomquist said. "He's got an incredibly dry sense of humor. And the kids absolutely love just his delivery, and they know that he just has a way with words, and he's just a very funny guy.'

One of the reasons Blomquist thinks Kenoyer is so special to the kids is that he is one of their class advisors. So, he has been involved since their freshman year.

They planned prom together, worked concessions together to raise money for the senior trip. He went on their senior trip with them, she said.

"I heard that he was racing him down the waterslide when they went out to the water slides in Chelan," she said.

Theo Allen was a CHS student in the early 2000s who would have graduated in 2006. But he passed away on the day after graduation in 2005 in a glider accident, Blomquist said.

"He was a very, very special student who wanted to, I think, eventually grow up and be a teacher, but he also wanted to honor teachers," she said. "So his family, after he passed away, made an honorarium to honor one teacher a year that emulated that thing that Theo stood for."

"It was just those things that Theo did, like seek out people that need help, going above and beyond, having excitement and fun with extracurriculars, and just always, always striving to be your very best.³

"His quote that he lived by was 'to give anything less than your best is to sacrifice the gift'," she said.

The quote is from Steve Prefontaine, a famous American long-distance runner.

"Theo was a runner, and so that was kind of cool that he had that saying, and I don't know if you're aware of this, but every single day at school, still almost 20 years later, we sign off our bulletin daily with 'to give anything less than your best is to sacrifice the gift'," she said.

Blomquist said the school has been honoring teachers in Theo's name since his passing.

Nearly 20 years after his passing, Theo Allen's legacy is still felt in Cashmere.

"We have a banner in our community center that says 'to give anything less than your best is to sacrifice the gift' and actually, last year's graduating class donated that sign for us so that we would not forget."

Cashmere Council greenlights NCESD internship contract, cable service hearing Set for June 24

CASHMERE - The Cashmere City Council convened on June 9 to discuss the upcoming summer operations at the Cashmere City Pool. Pool Manager Christie Bagley presented the expanded schedule and activities for the season, which can be accessed by the public on the city's official website.

During the meeting, Bagley informed the Council that she had conducted interviews with 15 potential lifeguards and currently has 13 enrolled in her new lifeguard class. The pool will be staffed with 8 returning lifeguards, 13 new lifeguards, and 3 new cashiers. Additionally, 11 employees have received training in swim lesson instruction. Bagley also announced that the pool will now be equipped with Internet access, allowing for convenient credit card payments.

Several groups have made arrangements to rent the pool throughout the summer. The Cashmere Swim Team, boasting 120 members, will utilize the pool for their practices. Cashmere Summer School has scheduled rentals for an hour on 12 different dates. The High School has also reserved the pool for 4 night swims, specifically aimed at accommodating migrant families. Bagley made a request to the community for donations of extra life jackets to support these events. Furthermore, Upper Valley Mend has generously provided swim lesson vouchers for 50 students from Vale Elementary School who would otherwise face financial barriers to accessing lessons. Due to the Leavenworth Pool not being operational yet, the Leavenworth Swim Team will also be renting the Cashmere pool.

In a separate announcement, it was noted that a public hearing will be held regarding a Master Cable Service Agreement to provide cable

Unprepared hikers rescued from snowy Maple Pass

WENATCHEE - On Monday, June 10, the Chelan County Sheriff's Office successfully rescued two stranded hikers in the Maple Pass area near Rainy Pass on Highway 20. The rescue operation was initiated after Rivercom Dispatch received a distress text message from the hikers at approximately 6:11 p.m.

According to Sheriff Mike Morrison, the two hikers were unable to move due to snow and were unprepared for the conditions they encountered. With daylight fading, the decision was made to deploy the Chelan County Helicopter and coordinate with Okanogan County Mountain Rescue.

The helicopter crew located the stranded hikers from the air and inserted two mountain

rescue team members onto the snow field above the hikers' location. The rescue team quickly reached the subjects and guided them to the waiting helicopter. The hikers, though cold and frightened, were uninjured. They were flown to the parking lot and met by Rick Balam of Okanogan County Search and Rescue. Due to the deteriorating light conditions, the two mountain rescue personnel had to hike out of the area.

Sheriff Morrison reminds outdoor enthusiasts that there is still a significant amount of snow present in higher elevations. He urges hikers to be prepared with the "10 Essentials" and to turn back when trail conditions become hazardous

The identities of the rescued hikers have not been released, and no further details are available at this time.

Land Trust secures 221.6-acre conservation easement above Wapato Lake

High-quality shrubsteppe and wildlife habitat protected

WENATCHEE — The Chelan-Douglas Land Trust (CDLT) announced Friday the acquisition of a 221.6-acre conservation easement near Manson. The easement, which protects vital shrub-steppe habitat and wildlife corridors, was secured through a collaborative effort between CDLT, Chelan County Public Utility District, and landowners Denis and Irmi Atam.

The newly conserved land, situated above Wapato Lake, had previously been subdivided into 10 parcels slated for residential development. However, the Atams' purchase of the property and subsequent partnership with CDLT and Chelan PUD has ensured that the land will remain predominantly undeveloped in perpetuity.

Mickey Fleming, CDLT's

Land Program Manager, praised the Atams' dedication conservation, stating, to "CDLT has been working with the Atams for several years to permanently conserve these beautiful 220 acres above Wapato Lake. The shrubsteppe habitat is home to a diverse group of wildlife whose territory is being constricted by development throughout the area. The Atams took the risk of buying the property that surely would otherwise have been developed. They then worked with CDLT and the Chelan PUD to complete a conservation easement that will protect the land forever. We at CDLT are very grateful to Denis and Irmi for their commitment to conservation and their faith in CDLT."

The preserved transitional pine zone habitat will provide sanctuary for a wide array of wildlife species, including mule deer, black bear, cougar, moose, elk, western gray squirrel, numerous bird species, and native pollinators. The property's adjacency to

public lands further enhances its value as a wildfire corridor.

Chelan PUD Commissioner Carnan Bergren underscored the utility's commitment to environmental responsibility, noting that the easement acquisition was funded as part of Chelan PUD's federal license to operate Lake Chelan Dam. "Chelan PUD is committed to stewardship and dutiful compliance with our Lake Chelan project," said Bergren. "After many years of trying to secure a site-we are excited to be celebrating this successful partnership. Many thanks to the Atam family for their willingness to enter this conservation easement. This project highlights what can happen when public entities (state and local), nonprofit agencies, and individuals work together with a shared vision and in the public's best interest."

For the Atams, the conservation easement represents an opportunity to safeguard the natural beauty and ecological integrity of the

region for generations to come. "We feel blessed living in such a beautiful environment and community," Denis and Irmi Atam shared. "After almost five years of collaboration with CDLT and Chelan PUD, we were finally able to obtain and implement a permanent conservation easement for a 221-acre parcel in the hills of Manson to preserve and

protect the wildlife, fauna, and flora. We hope we can inspire others to follow our path—our mantra is: 'Not everything which can be developed should be developed.'''

Since its founding in 1985, CDLT has been at the forefront of land conservation efforts in North Central Washington, protecting forty miles of recreational trails and twentysix thousand acres of diverse landscapes, including forests, shrub-steppe, wheat fields, and riparian areas across Chelan and Douglas counties. The Atam conservation easement marks another milestone in CDLT's ongoing mission to preserve the region's natural heritage and promote responsible stewardship of its resources.

Confluence Health tackles health inequities, prepares community for wildfire smoke

WENATCHEE — As wildfires become more frequent in North Central Washington, various departments and teams at Confluence Health are working to help the community prepare for and mitigate the negative health impacts of wildfire smoke, especially among vulnerable populations.

"As wildfires become more common in North Central Washington, it is important for us to prepare for the known health effects of wildfire smoke," said Dr. Bindu Nayak, an endocrinologist and the co-medical director of health equity at Confluence Health. Dr. Nayak and fellow

Confluence Health physician Dr. Saba Lodhi, a pulmonology specialist, recently contributed to an American Medical Association article discussing how climate change is increasing the severity and health risks of wildfires.

In the article, Dr. Lodhi discussed how the impact on public health comes "in two main ways: By changing the severity of existing health problems and by creating new unanticipated health problems." She added, "Exposure to this particulate matter [from wildfire smoke] increases respiratory and cardiovascular hospitalizations, clinic and emergency department visits, and medication dispensations for asthma and COPD."

"Children are more sensitive to the effects of wildfire smoke and children with asthma are one of the most vulnerable groups with regards to wildfire smoke exposure," said Dr. Nayak. "From our hospital data, we observed that Hispanic children with asthma in our community were affected with higher number of emergency department visits due to breathing problems during the wildfire season. We know that addressing health inequities proactively can help

tremendously."

In response, Confluence Health launched a pediatric asthma disparity action project to provide every child asthma and restrictive airway disease patient with an action plan and education to help them prepare for smoke. The materials are available in English and Spanish.

"To date, this project has been very successful as we have started to develop these action plans by putting pen to paper and outlining what can be done, while also getting feedback along the way on how to improve," said Dr. Ellen Mateo, a pediatrician at Confluence Health and one of those on the project team. "We have also reached out to community organizations, such as CAFÉ and local health fairs, as a part of our education efforts. Additionally, we have made a concerted effort to regularly follow up with asthma patients to keep their plans up to date and their asthma under control."

"Wildfire smoke can be very hazardous, especially to the young, elderly, and those with lung disease," remarked Jill Gustafson, a pediatric outpatient case manager at Confluence Health and another member of the ongoing project. "There are ways to prepare ahead of time to minimize and control its negative impacts on your family's health. One of the most important steps is to contact your doctor's office for an appointment to review and manage your lung health before illness or smoke strikes. Be proactive. You can control your asthma, so don't let it control you!"

Residents can monitor air quality for their zip code at AirNow.gov and find information about lung health and protection at Lung.org. The Chelan-Douglas Health District website at CDHD. wa.gov provides local wildfire smoke resources, including how to make or obtain air filters and masks.

LEAVENWORTH — The Chelan County Sheriff's Office is seeking the public's help in locating a missing man who was last seen in North Central Washington.

Joshua Dean Griffin, 37, was reported missing by his family in March 2023 in Colorado. He was found three months later, in June, working temporary jobs in Wenatchee, Washington, but went missing again in August 2023.

In April 2024, a backpack containing Griffin's clothing, wallet, identification and cash was discovered along a hiking trail near Leavenworth. A search of the surrounding area did not yield any clues to his whereabouts, said Detective Paul Nelson of the Chelan County Sheriff's Office.

Griffin is described as 5 feet, 7 inches tall and weighing 155 pounds. He was known to live a transient lifestyle, had a history of drug use, and often went for long walks, according to his family and friends.
