Leavenworth Senior Center brings community together with weekly lunches

LEAVENWORTH Wednesday, the Senior Center offers a chance for seniors to connect with one another over a nutritious, homecooked meal.

The weekly meals are \$8 for seniors, subsidized by funding support from the City of Leavenworth and various donors. They are made by scratch by saucier chef Jenny Hoffman, who runs her own catering business, Whatcha Got Cookin'.

Hoffman will prepare nostalgic classics like lasagna or pot roast alongside global dishes such as Chicken Tikka Masala, evoking memories of travel for some guests. All the meals are made with quality ingredients with nutrition in mind.

"Everything I try and do from scratch...I try and do as much as possible to kind of keep that nutrition and balance, so people are getting healthy meals and they're balanced. We've got some type of nice protein, starch, vegetable, fruit, so we kind of hit all those categories and a well

rounded meal," said Hoffman. While Wednesdays at the Senior

Center is where to find a good meal, it's also a place for seniors to get out of the house, meet up with old friends, and make new ones. When Hoffman started, she signed up her mother-inlaw, who lives in Merritt and, in her 80s, wasn't able to socialize much outside of family.

"She comes here to be able to talk with other people and have a social life, and have a community of people that are her age. She looks forward to coming every Wednesday to be able to get out of the house. And, she found out that she's related to somebody here, there's family history that goes back down the line," said Hoffman.

and coincidental meetings happen all the time at the Senior Center lunches. About a month ago, Bob Perleberg reconnected with the widow of his former dentist, and was able to make a connection with another longtime local resident.

"I enjoy the people here. About less than a month ago, there was a lady sitting over the table. She looked at me. She said, 'I know you...My husband was a dentist, and you were one of his patients," said Perleberg. "I told her one of

his hygienists works for the current dentist that I go to, so they still have a tie together.'

For Sally Monsey, the Senior Center became a place to meet new people after she lost her husband and returned to her hometown eight years ago. Having grown up in Leavenworth, Monsey fondly remembers participating in Rainbow Girls, a Masonic youth service organization, at the Senior Center building in the 1950s.

"The town has grown so much, and it gives the people moving in a good opportunity to meet, because we have so many retired people who have moved into the area,' said Monsey. "They come from all walks of life. We've had doctors and dentists and pharmacists and teachers and lawyers. You name it, we've had it here. So it's a good cross section of people in town.'

When she started attending the lunch eight years ago, she connected with local architect Ray Monsey, and the two married. Although Ray passed away in January, Sally Monsey still attends became a board member for the senior center.

"It's fun to get together. It's the camaraderie. I think it's important for the seniors to get out and participate in the city and just meet and greet so many seniors...I think this is a good way for them to be out, being with people," said Monsey.

On Dec. 18, the Senior Center will host its Christmas lunch free of charge to seniors. Hoffman plans to brine the turkey for 24-hours with orange, clove and cinnamon, and finish it with a homemade sage butter. The turkey will be accompanied by holiday classic dishes.

"Our focus is to just get people to sit down, to share the holiday season together, and to see old friends," said Corky Broaddus, a Senior Center Board Member and former president.

Wednesday lunches are open to anyone over the age of 50. To attend, the Senior Center asks that reservations be made by Tuesdays at noon by calling 509-548-6666. Reservations for the Christmas lunch should be made earlier in advance.

Leavenworth adjusts traffic restrictions for Village of Lights Festival

LEAVENWORTH - Leavenworth has made adjustments to its traffic restrictions for the Village of Lights festival to improve traffic flow and ensure public safety. The traffic restrictions were put in place this year to ensure clear routes for emergency vehicles during Village of Lights: Christmastown festival. The plan was put together by a collaboration of the City of Leavenworth, Chelan County Fire District #3, Chelan County Public Works, Chelan County Sheriff's Office, Chelan County Emergency Management, Cascade Medical, Washington State Patrol, Washington State Department of Transportation, and the Leavenworth Chamber of

During the first weekend of the festival, a "no left-turn" restriction from North Road onto Chumstick Highway led to traffic congestion, business disruptions, and unsafe U-turns as drivers attempted to return to downtown Leavenworth.

'Each agency shared its feedback and perspective on the efficacy of the joint public safety measures implemented over the past weekend. After the individual agency debriefs, the group collectively discussed potential improvements and/or proposed changes to the temporary parking restrictions and traffic revisions," said City of Leavenworth Communications Manager, Kara Raftery.

In response to these concerns, the

Jubilee Global Gifts finds new owners. continues mission of community support

LEAVENWORTH -Valley MEND announced the sale of Jubilee Global Gifts, a fair trade retail establishment, to local business owners Kirstie Miethe and Hans Mulders, continuing the store's role in supporting community initiatives. The store, established in the late 1990s by John and Mary Schramm, has helped fund MEND's community programs since 2011, when the founders donated it to the nonprofit organization. These programs include the Community Cupboard food pantry, Upper Valley Free Clinic, Affordable Housing, and Financial Assistance programs.

The sale represents a full-circle moment for Miethe, who previously served as the store's manager in 2020 and 2021 and has received assistance from MEND's programs. "MEND helped us, and now I get to help MEND. I managed Jubilee, and now I get to return as its owner," Miethe said. "I intend to continue to support MEND for many years."

Co-owner Hans Mulders, who operates the Obertal Inn with his wife

LEAVENWORTH Wenatchee River Institute (WRI) is rallying community support to ensure environmental education remains accessible for local youth.

WRI is working toward a fundraising goal of \$65,000 by the end of the year to support its environmental education programming, with the Icicle Fund pledging to match up to \$30,000 in donations. The campaign's focus is to ensure local youth can continue to benefit from nature-based learning experiences.

"These kids need nature moments now more than ever. WRI's programming is real - we walk the trails, splash in the river, and breathe the fresh air in every program and with every kid we can," said WRI Executive Director Canuche Terranella in a fundraising campaign letter.

WRI partners with schools for a majority of its youth programming, such as Field Day Programs,

Traveling Naturalist in the Classroom, After School Program, Traveling Planetarium. However, due to budget cuts and rising costs, many schools in the region have had to scale back or eliminate supplemental programs to focus on meeting basic needs.

"Just this year, 3 schools in North Central Washington have halted or reduced their programming with WRI due to budget cuts. This is a loss of at least one thousand hours of outdoor learning, impacting over 300 students," added Terranella.

WRI raised \$3,250 during Giving Tuesday, a global movement that encourages people to give back through donations, volunteering, or acts of generosity on the Tuesday following Thanksgiving, more than doubling the \$1,500 they raised last

"It has been so refreshing to see the great turnout of our community and pay witness to their support. Our community stands by our environmental education programming in schools. Our schools are having major funding challenges

right now, but the community sees the importance of maintaining that relationship," said Development Associate Randee Zerger in an email to Ward Media.

WRI is continuing to fundraise

through the end of the year. Donations can be made directly on their website, or through the Community Foundation of NCW's Give NCW, an

Where to find a Christmas tree this year

CHELAN COUNTY - With the holiday season underway, families in the Wenatchee Valley have several options for sourcing their Christmas trees, ranging from locally operated tree sales supporting community causes to permits for cutting trees in the Okanogan-Wenatchee National Forest.

For a convenient option with a good cause, Wenatchee's Best Christmas Trees offers a selection of noble, Fraser, Douglas, Nordmann, and grand firs, in addition to spruce. Prices range from \$40 to \$200, depending on size and type of tree. The trees are sourced from Lynden and Elma and are cut the day before pick up each week.

A portion of the proceeds supports local students in need. Brad Wagner, who operates the tree sales, says the funds are typically donated as gift cards for essential items, redeemable at places like Albertsons, American Shoe Shop, and Stan's Merry Mart. They are distributed to family liaison officers 🥿 in East Wenatchee and Wenatchee schools, who then provide them to families requiring assistance. Each Wenatchee's

noble, grand, and Nordmann fir trees, along with wreaths, garland, and tree supplies. Prices range from \$65 to \$175, depending on type and size. The farm is located on the corner of Grant Road and South Mary Avenue and is open at 11 a.m. on weekdays, and 9 a.m. on Saturdays and Sundays. Tree sales end at 6 p.m., according to the farm's Facebook page. Tree buyers can stay for the Nelson Family Lights show, which takes place from 5 p.m. to 9 p.m. at Annie's Fun Farm each night.

In Cashmere, Shelton's Tree Farm has seven acres of various spruce and fir trees for selection. Guests may choose to walk the farm to select their tree or call up to 24 hours in advance to pick up a ready-to-go tree, according to their website. Trees are \$120 for any kind, any size. On-site cutters can assist with cutting and transporting the tree to a vehicle, or guests may opt to cut the tree themselves with available handsaws. The farm provides twine for securing the tree for transport. The tree farm is open on weekends from 10 a.m. to 4 p.m. through Dec. 15.

Those looking to cut their own tree will need to acquire a \$5 Christmas tree permit to remove tree from the Okanogan-Wenatchee Natio-Forest. Permits can be purchased recreation. gov, from District offices, and various businesses. Free permits are available to all Fourth Graders with an Every Kid Outdoors Pass or voucher. Each permit is for one tree, and two permits may be issued per family.

The Forest Service recommends high clearance 4-wheel drive vehicles for winter forest road travel. traction devices, a shovel, warm clothing, blankets, flashlight, first aid kit, saw, tarp, and rope for securing the

The Forest Service has issued guidelines for where and how to cut trees within the National Forest. Trees cannot be removed within Wilderness Areas, fire closure areas, in active timber sale areas, or privately owned and state managed land within the National Forest boundary. Additionally, trees may not be removed from tree plantations, campgrounds, administrative sites, areas specifically posted, or within 150 feet of any stream, lake, pond, or wetland

Trees with a maximum height of 15 feet may be cut or dug up and removed. Cut trees should be cut with no more than a 6-inch stump remaining. Holes must be filled after digging up and removing a tree. After cutting or removing the tree, peel and attach the Christmas tree permit sticker by wrapping it around the tree trunk between limbs, where it is visible in transit.

Chelan PUD unveils 50-Year Strategic Vision, seeks public input on future plans

WENATCHEE — Chelan County Public Utility District unveiled its comprehensive 50-year strategic vision last week, introducing a new mission statement and longterm objectives for the public power utility.

The strategic plan, dubbed "Imagine 2075," outlines nine major goals for the utility's future and introduces a new mission statement: "Provide essential services to empower the community." The plan also establishes a new vision statement focusing on creating "bold, enduring value for future generations."

The PUD is actively seeking public input on the proposed plan, which has been in development for nearly a year. Residents can provide feedback via email at customeroutreach@ chelanpud.org or through a survey available on the utility's website.

The utility's board of commissioners will review public comments during their December 16 meeting.

During the same board meeting, commissioners addressed several other matters, including reviewing forecasts indicating increasing electrical demand throughout Chelan County. In response to projected growth, the board is evaluating the potential purchase of property in South Wenatchee for a new substation.

The commissioners also took action on the utility's financial planning, approving the 2025 operating and capital budget, which was initially presented on November 18.

State Patrol to enforce noparking zones along Stevens Pass

STEVENS PASS — Washington State Patrol officials announced that parking restrictions along Stevens Pass will be strictly enforced during the winter season, with vehicles subject to towing in designated no-parking zones.

The restrictions apply to both sides of State Route 2 between mileposts 58.50 and 66.44, covering a crucial stretch of the mountain pass. The noparking regulation is in effect from November 1 to April 1, coinciding with the peak winter recreation season.


"When the parking lots at Stevens Pass Ski Area fill up, drivers have resorted to parking along the highway," said Trooper Jeremy Weber of the Washington State Patrol. Weber noted that this includes recreational users "improperly parking in 'Tow Away Zones."


State officials emphasized that roadside parking poses multiple safety hazards, interfering with essential winter operations including snow removal and avalanche control. The practice also creates dangerous conditions for highway maintenance

personnel, skiers, and other highway users.

To address the issue, authorities have installed "Tow Away Zones" signs along the affected corridor to promote compliance among motorists. Law enforcement officials will be conducting active enforcement in these designated areas.

The event will raise funds for the Cascade School District's choir program through the Crescendo Campaign, a community initiative to preserve the middle and high

school choir program.

The Crescendo Campaign began earlier this year after the Cascade School District faced budget challenges that put its choir program at risk. The campaign aims to raise

\$65,000 per year to maintain the program through the 2025-2026 school year.

The benefit concert has a chance to help the campaign make the first year fundraising goal a reality.

LVV President Allison Bergstrom said it is important to LVV members to help support the school choir program.

"We're very proud to be able to support the choir program in our community," she said. "Part of our mission statement is to support the arts and the musical arts in our community. So we want to be able to make sure that the next generation of singers have opportunities and an outlet."

Mindy Wall is the director of both LVV and the Cascade High School Choir. So the benefit concert is special for her as well

"I think that music is something that kids need,"

Wall said. "I know that all of the research shows that kids who study music do well in all their other classes. I also think that music classes are a place of belonging for kids who maybe don't find their place in athletics, or, you know, other things, a lot of times, kids find their tribe in music.

"We just can't only concentrate on reading, writing, and arithmetic and expect our kids to to be well rounded students and citizens. They need to have other things. They need to have music and the arts."

The state of Washington requires all sixth graders to take a music class, and since the band program lacks the capacity to accommodate everyone, the choir is essential to meeting this requirement.

"But then on the more human scale and compassion scale, we just believe that there should be elective options for all the kids," Rome said. "Not all kids are going to be drawn to art or sports or academics, so having these different electives that can touch a student's heart is a huge part of what we want for our community."



Wenatchee Valley Humane Society's new director focuses on staffing, community engagement

Society appointed BJ Andersen as its new executive director on Nov. 4, following the departure of James Pumphrey in June. Andersen first began her career in animal welfare 20

years ago, when she applied

for a Kennel Manager position at the Willamette Humane Society. "I thought I was coming in to work with dogs, and what I really learned was that I was coming in to work with people...Every pet we serve has people attached to it. In some way, there are people

in that pet's story. And I

really love helping people,

particularly when it comes to

how they connect with animals

and the natural world," said Andersen.

In 2014, she became the Executive Director for Willamette Humane Society. In 2022, Andersen negotiated a merger with Oregon Humane Society in order to expand animal welfare resources in the Willamette Valley. After the merger was complete, Andersen served as the Senior Philanthropic Advisor to the president and CEO. Later, she assumed the role as Director

of Volunteer Engagement,

generating and implementing

training and management

systems for over 1,300

volunteers. Andersen said she had long admired Wenatchee Valley Humane Society's former executive director Dawn Davies's work to build the clinic, pursue progressive programming and meet the

community's needs.

"When the Wenatchee Valley opening came across my awareness, it just felt like a right fit for me. This shelter is similar in size and programming to what we created at Willamette Humane Society...I think that my experience here will really benefit the organization, the community," said Andersen.

In her new role at the Wenatchee Valley Humane Society, Andersen plans to apply her experience leading the similarly sized Willamette Humane Society, as well as her knowledge gained from the merger, such as scaling up a program, implementing good change management, and collaborating with the community to move through

significant changes. Valley "[Wenatchee Society]

definitely been through a lot of leadership changes in the last three or so years, and that's hard on an organization...I think one of the things that's really important in new leadership, in change management, is making sure that I am hearing from all the different voices, but I'm hearing from all the different perspectives, that everyone has a voice at the table, and that we communicate really clearly when we're making changes," said Andersen.

Andersen's highest priority for the Wenatchee Valley Humane Society is fully staffing the organization's clinic services.

"I'm definitely looking to recruit licensed vet techs for our program. Once we have that team fully staffed, I think we're going to be able to offer a lot more services to the

community, and I know that there's an incredible demand for those services," said Andersen.

In the future, Andersen said she also hopes to expand animal care and control officers in ways that are engaging with human and social services, as well as build partnerships with communities organizations within and neighboring the humane society's jurisdiction. For now, she plans to find ways to best support staff and engage with

"I'm finding the community really cares about this organization, and they really want the humane society to thrive and be successful. So I'm open to hearing what that means to people in the community, and helping them to understand where we're at and where we are on this path.

the community.

So it's going to be an ongoing conversation," said Andersen.
