## Local resources for sustainable holiday waste disposal

LEAVENWORTH - According to the Environmental Protection Agency (EPA), the amount of household garbage in the United States can increase by 25 percent between Thanksgiving and New Year's Day, from 4 million tons to 5 million tons. However, there are a number of local options to ensure post-holiday waste is disposed of sustainably.

Christmas trees may be composted through Winton MFG, a composting facility located near Cole's Corner, for a \$5 fee. The proceeds will be donated to Upper Valley Connection, a recreation program for youth and adults with special needs. Trees should be free of all tinsel and decorations before dropping off. Winton is open weekdays from 9 a.m. to 4 p.m. during the winter, and is located at 17400 Winton Road, Leavenworth.

Composting scraps and leftovers from holiday meals is also an option through the Winton's community composting program. Sign up for \$5 a month and receive a bucket for collecting food waste. Compost materials may be dropped off at a number of sites throughout the valley.

Before throwing any broken string lights in the trash, consider bringing them to the Leavenworth Recycling Center through the month of January. Waste Loop, a sustainability nonprofit that manages the center, will take the broken lights to Wenatchee Valley Salvage and Recycling, where they will be shredded into component parts such as copper, glass, and plastic, and recycled separately into new products.

Wrapping paper and cardboard may also be brought to the facility for recycling. However, not all wrapping paper is recyclable, such as metallic,

shiny, and glittery papers that are typically a plastic and paper composite. If paper excludes these elements but seems questionable, crumple it into a ball and see if it holds its shape. If it does, it is likely recyclable. If it doesn't, it should be saved for future gifts, or placed in the trash. Be sure to remove ribbons and bows before recycling, which can also be saved for next year's gifts.

Plastic bottles, aluminum cans, and paperboard can also be recycled at the center. Leave the New Year's champagne bottles at home however, as glass recycling is still on pause. Recycling center winter hours are Wednesdays from 3:30 p.m. to 5:30 p.m., with Saturday hours reopening on Jan. 4 from 11 a.m. to 3 p.m. The recycling center is located at 216 14th Street, Leavenworth.

Still uncertain about which materials should go where? Sustainable NCW's Waste Wizard is a comprehensive guide for properly recycling, reusing, donating or disposing of waste in Chelan and Douglas Counties. Options for items in question can be searched at: sustainablencw.org/wastewizard.

"We hope participants will leave inspired to continue to get to know, care for, and celebrate the diverse social and natural aspects of our communities," the event's website stated.



## Suspect identified in Front Street Park vandalism case

LEAVENWORTH - The Chelan County Sheriff's Office has identified Zachary Soltis of Texas as the suspect in the December vandalism of Front Street Park, also known as Gazebo Park. The incident, which temporarily disrupted holiday sledding activities, occurred around 1:00 a.m. on

December 22. According to the sheriff's office, Soltis allegedly drove a pickup truck recklessly through the park, causing extensive damage before fleeing the area. The sheriff's office has established probable cause for Soltis's arrest on charges of Malicious Mischief in the Second Degree and

Reckless Driving. The incident was captured on camera, with members of the car interest group Street Phantoms present during the vandalism. A photographer using the Instagram handle 509.visuals\_, who was part of the group, previously stated they had provided authorities with evidence and information about the driver.

The city temporarily closed the park on December 22 to

assess and repair the damage, which included deep rivets in a 90-by-50-foot section of lawn typically used as a sledding hill during winter months. Thanks to city staff efforts and recent snowfall, the park has since reopened to sledding over the holiday week.

"The Chelan County Sheriff's Office, City of Leavenworth, and Leavenworth Chamber of Commerce are working together to accurately assess the extent of damages," said Kara Raftery, City of  $Leavenworth \, Communications$ 

and Special Projects Manager. Chelan County The Sheriff's Office is working with the County Prosecuting Attorney's Office to file formal charges against Soltis.





# Cascade High School's Mia Dreis wins national title for STEM-themed children's book


LEAVENWORTH - Cascade High School senior Mia Dreis earned national recognition this past summer when she took first place at the Technology Student Association's (TSA) 2024 National Conference for her illustrated children's story, How Otto Found His Way.

"When they called my name, I was completely shocked. Not for a second had I thought that winning was going to be the reality of it. I was really proud and just blown away, Dreis recalled of the moment she stood on stage during the awards ceremony.

TSA is a national non-profit organization that provides middle and high school students with opportunities to compete in various science, technology, engineering, and mathematics (STEM)-related including robotics, software development, and even board game and architectural design. Students select a category to compete in and spend the school year developing a final project. For Dreis, that category was the Children's Story.

"I have learned that even though you think something that you've made or done deserves a certain level of recognition, it might not actually be true, and you really need to delve deeply into your process and take down your ego a little bit to succeed," Dreis said, reflecting on her years of competition in the category. With more than 300,000 students competing nationwide each year, the competition is fierce. Only the top three students from the state-level competition can advance to the national stage.

The prompt for the year's

Children's Story competition called for participants to create an adventure story with a STEM focus, incorporating clues that could be pieced together at the end. Dreis rose to the challenge by skillfully incorporating science concepts while keeping the language simple and accessible for young  $readers\, and\, includes\, detachable$ puzzle pieces on each page that can be assembled to complete the story's puzzle. The reader follows Otto, a curious robot, who embarks on an accidental adventure in the woods, solving scientific challenges to find his way home.

"I knew that it was one of my last chances, as it would be one of my last years participating in TSA. So, I needed to try really hard, and I was excited to put forth the effort," Dreis said of her determination. "I am glad that I participated in TSA because it made me realize that there are a lot of

different types of career path possibilities in STEM fields. It's not just coding and robotics. It's a lot of other things, and people with all different types of skills

can succeed." The experience of competing at the TSA Nationals in Orlando left a lasting impression on Dreis. "Besides the competition itself, my favorite part of the TSA National Conference in Orlando was seeing all the different students from around the nation and the world come together over shared interests. There were so many perspectives and passions united under TSA."

Dreis's achievement also highlights the strength of TSA within the Cascade School District, where students consistently outperform those from larger schools and specialized programs. For students considering TSA, Dreis has this advice: "Delve deep into the many diverse

events that TSA has to offer. While robotics, coding, and highly traditional STEM events are worthwhile, TSA also supports much more underrepresented STEM pursuits such as fashion design and architectural modeling."

As for her own future pursuits, Dreis shared that she plans "to attend college in the hopes of getting an engineering degree, a design degree, or a combination of the two. My ultimate goal is to one day work for Disney as one of their 'Imagineers,' a coveted position where one contributes to the artistic side of Disney's creations."

Ferguson keeping Batiste as Washington State Patrol chief

OLYMPIA - Washington State Patrol Chief John Batiste will soon be serving under his third chief executive.

Gov.-elect Bob Ferguson on Thursday announced Batiste's reappointment to lead the statewide law enforcement agency, a job Batiste has held for nearly two decades.

Also Thursday, Ferguson announced he's retaining three other members of Gov. Jay Inslee's administration: Joel Sacks as director of the Department of Labor & Industries, Allyson Brooks as director of the Department of Archaeology and Historic Preservation, and Bill Kehoe as director of Washington Technology Solutions and the state's chief information officer.

"With our challenges ahead, proven and thoughtful leadership is more important than ever," Ferguson said in a statement. "I am proud that these four individuals will continue their service."

On Friday, he said he was reappointing three additional agency leaders: Drew Shirk as director for the Department of Revenue, Scott McCallum as superintendent for the Washington State School for the Blind and Shauna Bilyeu as executive director for the



Batiste could be a prominent figure in advancing Ferguson's public safety agenda, which includes securing funding to help cities and counties hire officers and increasing safety

on the state's roadways.

Batiste joined Washington State Patrol in March 1976, earning promotions through the ranks of sergeant, lieutenant, captain, and deputy chief.

In 2005, then-governor Christine Gregoire appointed him to be the state patrol's 21st chief. Gov. Jay Inslee kept him on when he took office in 2013 and Batiste is set to begin work for Ferguson on Jan. 15, 2025.

The Washington State Patrol has 1,100 positions budgeted for commissioned officers and 1,100 for civilian employees. Of its six bureaus, field operations is the most

visible as it is responsible for traffic law enforcement, collision investigation, and motorist assistance on 17,524 miles of state and interstate highways.

The state's crime lab and fire marshal are housed in the agency. And the Investigative Services Bureau includes the Firearms Background Division, a point of contact for all firearm-

related background checks. Sacks has led the Department of Labor and Industries since 2013. The department oversees Washington's workplace safety laws and workers' compensation insurance and program, enforces

the state's wage and hour requirements.

In a release, Sacks said he was honored to join the Ferguson administration.

"I'm passionate about worker safety, and proud of what we've accomplished. As long as there are people hurt and killed on the job, we have a lot more to do," he said.


